# **Background and Context**

The Climate Action Network Uganda (CAN-U) is a national network of civil society organisations, private sector, academia and individuals working to advance climate action in their respective jurisdictions. CAN Uganda was formally inaugurated on the 9<sup>th</sup> April 2009 at Hotel Africana as a loose network with over 540 members. It was first hosted by Oxfam GB (Now Oxfam in Uganda) and supported by entities such as DENIVA, Actionaid Uganda and Uganda Redcross among others. Currently, CAN-U has 186<sup>1</sup> registered members across Uganda and has a fully established Secretariat.

Since 2021, CAN Uganda has been involved in the work of reviewing the National Forest Policy 2001. During this process, CAN Uganda supported civil society consultative meetings at national and community level to seek for views that would be used to shape and influence the outcome of the Policy. CAN Uganda co-sponsored the National Validation Meeting and also one technical review meeting that made additional inputs into the revised policy document. Our core interests were on reforms to consider rights of indigenous and forest dependent communities, climate proofing the policy and other reforms such as forest extension services, carbon trading and associated rights for the rights holders and role of community forestry in enhancing climate action among others. These were expressed in a joint position statement submitted to the Ministry of Water and Environment's policy review task team.

So far, the Forest Sector Support Department (FSSD) indicates that a draft of the revised National Forestry Policy is now available pending perusals and feedback from the Cabinet of the Government of Uganda. This will be very useful as material for use during the production of the technical note for the proposed review of the existing National Forest and Tree Planting Act (2003).

## **Objectives**

The main objective of the technical note is to influence the outcome of the proposed National Forest and Tree Planting Act in line with the current policy proposals and views submitted by the civil society during the consultative process of the policy.

More specifically, it is intended to:

- 1. contribute technical advice on the design and review of the existing National Forest and Tree Planting Act in line with the proposals of the revised Forest Policy.
- 2. provide recommendations for consideration by the government legal team during the consultative process for the review of the NFTPA (2003)
- 3. facilitate where necessary the civil society's contribution of legal issues during stakeholder consultations by providing legal guidance on key issues.

### Scope of work

The following are the tasks to be undertaken by the candidate:

- Review the revised National Forest Policy to pick out key issues for consideration in the review of the NFTPA (2003)
- Produce a technical paper/note to guide the review of the NFTPA (2003). This paper/note
  will be submitted to the Ministry of Water and Environment as an advance technical
  guidance for the review of the existing Act.

## **Duties and Responsibilities**

- Desk review of all available literature
- Stakeholder meetings.
- The consultant is expected to provide a detailed reasonable methodology during the application process and should be part of the technical proposal
