Under a Memorandum of Understanding CAN-U is affiliated to CAN- East Africa, CAN – Africa and CAN International. It is registered with the Uganda Registration Services Bureau (URSB) as a company limited by Guarantee. CAN Uganda is governed by the General Assembly which elects the Executive Board of Directors that oversee the functioning of the Secretariat made up of technical staff that run the day-to-day operations of the network.
